Management of open spaces over Easter

In the lead up to the Easter long weekend councils are urged to continue to work closely with Police Local Area Commands to support them in enforcing <u>Public Health Orders</u> and maintaining public health and safety generally.

Councils are also reminded of the powers they have to manage public places under their care and control. For example, under the Local Government Act 1993 councils may issue orders, abate public nuisances and/or erect notices that effectively close beaches, public baths and/or parks where councils have concerns that members of the public are creating public health and safety risks, such as not maintaining social distancing required at this time.

Before closing public spaces or taking other widespread regulatory action across their local government areas, councils should engage with Police Local Area Commands about the specific public health and safety concerns they have leading to their decision to take that regulatory action.



Planning and Assessment webinar now online

Everyone can now listen to the webinar for council general managers held on 30 March.

General managers from across the State participated in the webinar during which they received a briefing from Group

Deputy Secretary Marcus Ray and Chief Executive Local Government Tim Hurst on the latest COVID-19 developments.

Councils also submitted questions which were answered during the webinar. These covered a range of topics including managing planning functions, managing planning proposals and planning instruments, exemptions and change of use provisions and planning panels.

Sector survey helping to create safer communities

Since late March OLG has asked councils to complete an online form answering specific questions about their response to COVID-19 and providing an opportunity to raise questions or issues they are grappling with.



Many councils have made completing this form a priority, understanding that it allows OLG to collect and respond to the issues raised by the sector, and most importantly to direct the questions to the responsible agency through OLG's participation in the State Emergency Operations Centre (SEOC).

Since OLG started collecting the data councils have been able to receive guidance on a wide range of issues raised, including:

- conduct of council meetings
- postponement of council elections
- clarification around the operation of caravan parks and travellers through recent public health orders
- access to social media collateral to advise people to stay at home these holidays and strong government messaging on that theme
- access to webinars with the Minister for Health and the Chief Medical officer

OLG is continuing to work hard on behalf of councils. This work is greatly helped by input from the sector and councils dedicated to the continued provision of services to the community, in a manner that protect both community members and staff and keeps everyone safe.
