## Police to enforce Stay Home orders over Easter

The Traffic and Highway Patrol Command is reminding the community that travelling for holidays is not considered 'essential' travel and officers will be out in force over the Easter long

weekend to ensure compliance.

The NSW Premier and the NSW Health Minister have outlined orders under the Public Health Act that state a person must not leave their home without a reasonable excuse.

Officers will be checking number plates for interstate travellers and questioning motorists if they appear to be outside their home without a valid reason.

These rules do not prohibit people from going to the supermarket and pharmacy, going to and from work if you cannot work from home, going to medical appointments, or leaving for some brief exercise in your own neighbourhood. Operation Tortoise, a state-wide road safety operation over the Easter long weekend, will see officers targeting speeding, mobile phone, seatbelt and motorcycle helmet offences; all of which will attract double demerit points.

Double demerit points will commence from 12.01am on Thursday 9 April and be in force until 11.59pm on Monday 13 April.



## Achieving financial targets in the face of COVID-19

As COVID-19 continues to impact communities throughout NSW, OLG understands that many councils will face difficulties in balancing their budgets and achieving their financial targets.

These are unprecedented times for

councils and OLG will work to ensure that the audit process acknowledges the challenges councils face and that financial performance will inevitably be affected.

OLG understands that councils are facing additional expenses, significant reductions in revenue, and challenges in ensuring the ongoing delivery of important community services.

Financial management strategies will need to be flexible and adaptable and OLG will take a pragmatic approach to council performance this year. No council should be considering reducing services or staffing just to demonstrate compliance with financial benchmarks.

In the coming months, as councils respond to the COVID-19 pandemic they should continue to make sound financial decisions which includes continuing to meet ongoing financial obligations.

The NSW Government is currently considering how best to support and sustain the local government sector during this difficult time. Meanwhile, any council that is concerned with its financial position should contact OLG.

## Caravan park and camping ground exemptions in amended Public Health Order

Heading into the Easter long weekend and school holidays a reminder for



councils as to the amended rules in relation to caravans and camping grounds.

Under the amendments caravan parks and campgrounds are to be closed except to accommodate:

- permanent residents of the caravan park or camping ground
- overnight travellers
- persons working in the local area
- other persons who have no other place of permanent residence or whose primary place of residence is temporarily unavailable and,
- persons who are visiting those who meet the above criteria
