NSW-Victorian border closes from tomorrow

The border between NSW and Victoria will be closed from 12.01am tomorrow (July 8).

This means Victorian residents will only be able to enter NSW for very limited reasons, such as obtaining medical care or fulfilling a legal obligation.

Special conditions will also be in place for freight operations and other critical services.



The requirement for NSW residents returning from Melbourne hotspots to selfisolate for 14 days will be extended to anyone returning from Victoria.

Heavy penalties and fines apply.

Provisions will be in place for residents of declared border regions, such as Albury-Wodonga.

The Office of Local Government will continue to work with local councils to address issues in relation to the temporary closure of the border.



Applying for a border permit

From 12:01am tomorrow (July 8) anyone wishing to travel from Victoria to NSW will need to apply for a COVID-19 NSW border declaration permit.

Service NSW will administer the permits through <u>this page</u>, with more information to be made available shortly.

All questions regarding the permits should be directed to Service NSW.

New Public Health Order to be issued

Councils are advised that an updated Public Health Order reflecting the Victorian-NSW GOVERNMENT temporary border closure will be issued shortly and available on the Legislation NSW site.

Commissioner McTavish updated councils on the temporary closure of the border with Victoria. The update was followed by a Question and Answer

session, including how the closure will affect cross-border workers, shopping for essential items over the border, and required isolation periods.

The webinars are part of a series coordinated by Minister for Local Government Shelley Hancock with relevant Ministers and public officials across Government to keep mayors and general managers up to date on the latest COVID-19 information and answer their questions.
