- We also know when things are changing rapidly Local Government is the first point of contact for many in the community.

Example messaging: NSW / VIC Border closure

We must protect the gains made

- The NSW Government has closed the border with Victoria
- We have protected each other and our local community by doing the right thing
- Now we must protect the gains we've made. Our priority must and always will be the health of NSW communities, including our own
- This is the right decision. This is about saving lives

Let's do the right thing

- This closure of the border with Victoria means new restrictions are in place. Those who don't do the right thing will face heavy fines and penalties. There will be little or no tolerance
- We know it will be particularly hard for communities on the border and those with family in Victoria
- People travelling from Victoria will be prevented from entering NSW unless they have a permit. There are rules governing the movement of communities in a border community and who can and how to apply for a permit
- This includes for essential and emergency service workers, if you provide care for someone, if you have children attending school/taking your child to school or if you need to see a doctor or access services
- As the situation is constantly changing, the requirements may also be adapted so we all stay safe and to minimise inconvenience

- We ask that people remain patient during this difficult time

We know what needs to be done to maintain the path we are on

- We cannot risk keeping our borders open for people coming from areas of Victoria right now
- If we want to keep our community safe, to continue to open businesses, to get sport back, we must do what is needed
- We are confident the Victorian Government, and the people of the State, will get to grips with this outbreak soon
- But NSW is not immune from the risk of renewed outbreaks, so we have to take action
- If we do the right thing, we will be back together again

NSW-VIC border closure: Protecting the health of our community

We protected our local community by doing the right thing. Now we must protect the gains we've made.
