Border closed to protect NSW

NSW will temporarily shut its border with Victoria to contain the spread of COVID-19 and protect citizens.

The closure will be effective from 12.01am Tuesday 7 July to all Melbourne residents, and from 12:01am Wednesday 8 July for all Victorians, following the concerning spread of COVID-19 in Melbourne.

NSW residents returning from a Melbourne hotspot are already required to go into 14 days of self-isolation. This requirement will be extended to anyone returning from Victoria. This will be backed by heavy penalties and fines.

There will be provisions in place for residents of border regions, such as Albury-Wodonga.

Special conditions will be in place for freight operations and other critical services.

The Office of Local Government will be working with local councils to address issues in relation to the temporary closure of the border.
