



#### How does the order work?

- The September elections have been postponed under an order made under section 318C of the Local Government Act 1993.
- The order revokes the former order made under section 318B of the Act, (which postponed the election requirements of the Act for all councils to 4 September 2021), and appoints 4 December 2021 as the day on which ordinary elections for all councils are to be held.
- An order under section 318C can only be made once.
- The order also appoints 4 December 2021 as the day on which by-elections are to be held to fill casual vacancies occurring between the date of the order (24 July 2021) and 4 December 2021 this means that casual vacancies will be filled at the ordinary elections on 4 December.
- In practical terms, this means that councils are not required to hold by-elections to fill casual vacancies between 24 July and 4 December 2021 or to apply to the Minister to dispense with this requirement.
- However general managers must still notify OLG, LGNSW and the NSWEC of vacancies within 7 days.



#### What does it mean for the current terms of councils, mayors and councillors?

- Current councillors will continue to hold their civic offices until council elections are held on 4 December 2021.
- Popularly elected mayors will continue to hold their civic offices until council elections are held on 4
  December 2021.
- The terms of mayors elected by councillors in September 2019 will expire in September 2021 and mayoral elections must held in September. Mayors elected in September 2021 will hold office until 4 December 2021.
- Mayors elected in September 2020 will continue to hold office until council elections are held on 4
  December 2021.
- Deputy mayors hold their office for the term specified by the council's resolution. If a deputy mayor's term expires before election day on 4 December 2021, an election may need to be held for deputy mayor councils are not required to have a deputy mayor.



#### What does it mean for the current terms of councils, mayors and councillors?

- Chairpersons of county councils now hold office for two years Chairpersons of county councils elected in September 2020 will continue to hold office until council elections are held on 4 December 2021.
- The composition of joint organisation boards may need to change in September 2021 as a result of mayoral elections.
- Chairpersons of joint organisations elected in 2020 will continue to hold office until council elections are held on 4 December 2021.



#### What happens now?

- All current serving councillors, members of county councils and voting representatives of the boards of joint
  organisations must lodge a written return of interests with the general manager (or the executive officer in the case
  of joint organisations) before 30 September 2021 unless they have submitted a return within the previous three
  months.
- The caretaker period no longer commences on 6 August 2021 the caretaker period for the 4 December 2021 elections will now commence on 5 November 2021 and end on 4 December 2021.
- The "regulated period" is the period commencing 40 days before elections in which rules regulating "electoral material" as defined by the Regulation come into effect. The regulated period no longer commences on 26 July 2021 the "regulated period" will now commence on 25 October 2021 and end on 4 December 2021.
- The end of term report must be presented at the final meeting of the outgoing council before the elections on 4 December 2021.
- · OLG will be issuing updated guidance on caretaker and other requirements.



#### What happens after the election?

- Elections are unlikely to be declared until 21 23 December 2021. Councils should schedule the timing of their first meetings following the election on this basis.
- Councils that elect their mayors are required to hold a mayoral election with 3 weeks after the declaration of the
  ordinary election and will be required to schedule a meeting for this purpose within 3 weeks of the declaration of
  the election.
- At the first council meeting after the election:
  - all councillors must take an oath or make an affirmation of office councillors are not permitted to participate in meetings until they have done so
  - ➤ councils must, by resolution, declare that casual vacancies occurring in the office of a councillor within 18 months of the election are to be filled by a countback if councils want to fill vacancies by these means councils that do not resolve to fill vacancies using a countback at their first meeting after the election will be required to fill vacancies using a by-election
  - > councils that elect their mayors must hold a mayoral election and an election for deputy mayor where they have one.



#### What happens after the election?

- At their first meetings after the election:
  - > joint organisations must elect a new chairperson
  - > county councils must elect a new chairperson and councillors must take an oath or make an affirmation of office.
- The postponement of the elections will not affect the timing of future council elections, and the subsequent ordinary local government elections will still proceed in September 2024 – this will mean the next term of councils will be for just under three years.
- Mayors elected by councillors will have shorter terms than the usual 2 years mid term mayoral elections will need
  to be held in September 2023 and mayors elected at the mid-term mayoral election will hold office until the
  ordinary elections in September 2024.
- The postponement of the elections will not impact on councils' IP&R cycles councils are still required to review
  the community strategic plan before 30 June 2022 and establish a new delivery program to cover their principal
  activities for the 4-year period commencing on 1 July 2022.

# **Elector Information – Voting options**

- Postal Voting same criteria as previous elections plus
  - are a permanent or temporary resident of a declared facility
  - are self-isolating because of COVID-19 related reasons
  - reasonably believe that attending a polling place will pose a risk to the health or safety of yourself or people around you, because of the COVID-19 pandemic.



- iVote eligibility criteria applies (same as State)
  - are blind or have low vision

- have a disability
- require assistance to vote because you are unable to read or write
- are not within 20 km of a polling place

are a silent elector

- outside council area
- Pre-poll Voting all electors eligible for LG21
- Election Day
