RE: Recruitment of General Manager - Wingecarribee Shire Council

The Southern Highlands Chamber of Commerce acknowledges Council is seeking to fill the position of General Manager Jurrently occupied by Acting General Manager Mr. Barry Paull proceeding the departure of the Shire's General Manager, Ms. Ann Prendergast in July 2020.

The Chamber strongly opposes the appointment of a new General Manager by this current cohort of elected Councilors due to the imposition of a Performance Improvement Order on Council by the Minister of Local Government, the Hon. Shelley Hancock.

We are calling for the appointment of the General Manager to be deferred until after the Local Government election which is to be held on September 4, 2021. We believe that the recruitment of the new General Manager should involve an extensive national and international search to find the best candidate and that this process should be overseen by the newly elected Council.

The current short recruitment process, internally managed and overseen by a Council which is currently under a Performance Improvement Order is completely inappropriate and will serve incumbency, which the Chamber does not believe is in the best interest of the region or the business community.

The future new group of democratically elected Councilor should be afforded the opportunity to vote on a new General Manager that they can work with collaboratively and not one that has been involved with a Council under a Performance Improvement Order.
